Company Background

MISSION STATEMENT: ActNow is a youth led theatre company that tailors socially conscious theatre projects. We engage with professional artists and diverse communities, using theatre to facilitate conversations around challenging, contemporary issues.

ActNow's work has been critically acclaimed, commended in South Australian Parliament and highly praised by audiences, participants and community organisations. The company creates youth led, high quality, thought provoking, socially relevant theatre with significant community impact.

COMPANY HISTORY: ActNow is a youth led theatre company "with an immense depth and maturity" (Independent Weekly), "unique in the current Australian theatre climate" (Lowdown Youth Arts), producing "independent theatre at its finest" (Australian Stage Online).

Formed in 2007 as a street theatre ensemble led by Edwin Kemp Attrill to highlight the situation of David Hicks, ActNow's beginnings were in developing street theatre projects with young people on political issues. In 2009 the company presented its first staged work *The Revolution Starts Here*, written by two young emerging playwrights. In the same year, the company began working on a contemporary queer adaptation of *A Midsummer Nights Dream*, and in 2010 the company presented Ibsen's *An Enemy of the People*, later described as the 2010 Best Independent Theatre Production (The Sunday Mail). From 2008-2010 the company presented annual theatre for social change conference *RightAct*, consisting of workshops, forums and performances. In 2010, ActNow began a partnership with the Legal Services Commission of South Australia to develop *Expect Respect!* an interactive performance about the legal implications of rape and sexual assault, which was performed 68 times between 2010 and 2012.

From 2011-2012 emerging writer/director/playwright Sarah Dunn took on the role of Artistic Director with the company. In 2011 the company supported new work Alice and Peter Grow Up, and in 2012 was commissioned to develop a performance about young peoples' perception of success for the Don Dunstan Foundation. In 2012 Edwin Kemp Attrill returned to the company in the new role of Company Producer.



Company Producer Report



The last twelve months have been a huge period of change, growth and maturity for the company. In mid 2012, I worked closely with former Artistic Director Sarah Dunn, Chairperson Kristy Megaw and the Board of Management to identify the strengths of the company and establish the most effective way forward. We decided to hone the company's primary focus to work in-schools and, in partnership with NGO's, create engaging, interactive, issue based theatre. My role since then has primarily involved

establishing a business model and strategic plan to achieve this.

It has been a period of experimentation which has certainly paid off.

The year of 2012 was primarily focused on restructuring the company, building organisational capacity and planning projects for 2013. ActNow has maintained a strong profile and has always had good support from the industry.

So far this year, the company has redeveloped and launched *Speak Out* - an interactive performance addressing homophobia in high schools - based on the hugely successful model of *Expect Respect*. The project has been performed several times, and the company has successfully secured a partnership with Feast Festival and funding for 30 performances in late 2013, including two weeks of regional tours.

At the start of the year, the company began a partnership with RiAus to develop a show exploring the science of ageing. With a commissioned script from local playwright Emily Steel and a very fine ensemble of actors, the company created one of it's best successes yet, *The Clock*, which ran a successful regional high school tour, but also clearly struck a chord for older audiences.

In addition, the company has re-developed long standing project *Expect Respect*, to focus on a value-based health approach. We were honoured to be invited to present the performance at the international White Ribbon Conference in Sydney in May 2013.

So far 2013 is shaping up to be our best year yet. I'm incredibly thankful for the support and guidance of the Board of Management, especially Kristy Megaw, and to Sarah Dunn, who have supported the company in my absence.

It's bloody good to be back.

Chairpersons Report



The last 12 months have seen a significant period of change for ActNow. The company has gone through a large range of changes and developments in this period and as a result has seen dramatic changes in the breadth of opportunities for the company. The Board of Management has developed a number of key policies to provide the company with a strong foundation moving forwards. The artistic output of the company has increased this year and been at an exceptionally

high standard. We have established numerous partnerships with NGO's and funding bodies, and significantly furthered our brand amongst the industry, general public and schools, most notability in regional areas. There has been a strong diversification of revenue, and a marked increase in income for the company during this period.

At our July 2012 AGM, we approved changes to the constitution to remove membership of the company, streamline the process of co-opting board members and simplify the management structure of the company to better reflect the existing situation of the company. This has proved to be significantly beneficial for the company with a stronger focus on Company 'basics' such as policies, budgeting, mix of board attributes and so forth.

In August 2012, we appointed ActNow founder and former Artistic Director, Edwin Kemp Attrill as the Company Producer on a part-time contract to develop the business model of the company. Edwin is an asset to the company and has been key to the success of the new model over the past twelve months.

I would like to thank outgoing Board Members Gemma Sneddon, Catherine Story and Shaylee Leach for their hard-work and commitment to the company. I would like to thank former Artistic Director Sarah Dunn for her time in the role, and congratulate her on entering the Flinders University Directors Course.

I would also like to welcome the several new Board Members who we've appointed during 2012-2013. Each member has brought a diverse range of skills and experience to the Board of Management and have already made a huge contribution to the management of the company.

Now that ActNow has the built a strong foundation, the next period will see the company develop product, branding and increase in market strength.







